1. Introduction

The Pathogen Asset Control System (PACS) is a comprehensive, flexible software solution for accounting for and tracking biological materials in laboratories. PACS has been developed under the Biological Threat Reduction Program (BTRP). It facilitates the monitoring of the reception, transfer, movement, destruction and other actions with biological materials of all kinds throughout their lifecycle.

The current document describes release notes for PACS v5.8.834.

2. PACS v5.8.834 Scope

This release of PACS v5.8.834 supports installation on any version of SQL Server 2012 and higher, on OS Windows 7 and higher.

PACS v5.8.834 supports the following versions of SQL Server: 2012, 2014, 2016, 2017, 2019. PACS 5.8.834 setup installs new PACS database by means of SQL scripts and BULK insert utility instead of restoring backup procedure. New version of PACS supports installation on SQL Server with any Collation settings (these settings can be configured for SQL Server once and cannot be modified later) and minor configurations.

Patch also includes fixes to issues based on SpiceWorks tickets.
